1 (i) The contract of purchase or other expenditure is for the 2 procurement of professional or technical services, including architectural, design 3 engineering, legal, medical, technological, or technical services; and

4 (ii) The County Commissioners have authorized the award of 5 the contract on the basis of the qualifications, resources, and experience of the bidder, 6 regardless of whether the bidder is the lowest bidder] **BID**.

8 THE COUNTY COMMISSIONERS MAY AWARD A CONTRACT OF PURCHASE 9 OR OTHER EXPENDITURE FOR THE PROCUREMENT OF PROFESSIONAL OR 10 TECHNICAL SERVICES, INCLUDING ARCHITECTURAL, DESIGN ENGINEERING, 11 LEGAL, MEDICAL, TECHNOLOGICAL, OR TECHNICAL SERVICES, ON THE BASIS OF 12 THE QUALIFICATIONS, RESOURCES, AND EXPERIENCE OF THE SERVICE 13 PROVIDER AND IS NOT SUBJECT TO THE REQUIREMENTS OF § 1–106 OF THIS 14 SUBTITLE.
