- 4 FOR the purpose of requiring certain county boards of education to make certain  $\mathbf{5}$ certifications regarding a certain curriculum on or before a certain date each 6 year; requiring the State Department of Education to develop a process to  $\mathbf{7}$ monitor certain implementation of a certain curriculum; requiring the 8 Department to report certain information to the Governor and General 9 Assembly on or before a certain date each year; and generally relating to the monitoring and implementation of the Personal Financial Literacy State 10 Curriculum 11

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 MARYLAND, That the Laws of Maryland read as follows:

- 21 (A) ON OR BEFORE SEPTEMBER 1 OF EACH YEAR, EACH COUNTY
- 22 SUPERINTENDENT SHALL CERTIFY TO THE STATE SUPERINTENDENT THAT THE
- 23 PERSONAL FINANCIAL LITERACY STATE CURRICULUM IS BEING TAUGHT IN
- 24 THE COUNTY.

1 (B) THE DEPARTMENT SHALL DEVELOP A PROCESS TO MONITOR 2 IMPLEMENTATION OF THE CURRICULUM AS CERTIFIED UNDER SUBSECTION (A) 3 OF THIS SECTION.

4 (C) ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE DEPARTMENT 5 SHALL REPORT TO THE GOVERNOR AND, SUBJECT TO § 2–1246 OF THE STATE 6 GOVERNMENT ARTICLE, TO THE GENERAL ASSEMBLY, REGARDING THE 7 MONITORING AND IMPLEMENTATION OF THE CURRICULUM.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2010.
