- 3 FOR the purpose of requiring applicants for a license to practice clinical marriage and 4 family therapy to hold a master's or doctoral degree in a certain field from an 5 accredited educational institution that is approved by the State Board of 6 Professional Counselors and Therapists; altering the number of credit hours in 7 alcohol and drug counselor training that are required for qualification as a 8 certified professional counselor-alcohol and drug or certified association 9 counselor-alcohol and drug; and generally relating to corrections of the Maryland Professional Counselors and Therapists Act. 10
