2 **Nursing Facility Residents – Home-Based and Community Services – Access**
3 **Assistance**

4 FOR the purpose of requiring social workers to provide certain nursing facility
5 residents with certain information about certain services under the home- and
6 community-based waiver programs on admission and discharge from the
7 nursing facility; ~~requiring the Department of Health and Mental Hygiene or the~~
8 ~~Department's designee to provide certain information to certain nursing facility~~
9 ~~residents within a certain number of days; requiring the Department to provide~~
10 ~~certain assistance to certain residents within certain time frames; requiring~~
11 certain employees or representatives of certain designated protection and
12 advocacy systems agencies to have certain access to certain residents; providing
13 for the confidentiality of certain information provided by a nursing facility
14 resident to employees or representatives of designated protection and advocacy
15 systems agencies; ~~prohibiting a nursing facility from denying certain employees~~
16 ~~or representatives access to certain nursing facility residents; providing for a~~
17 ~~certain penalty and appeal procedures; defining a certain term; and generally~~
18 relating to providing nursing facility residents access assistance to home-based
19 and community services.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article – Health – General**

5 15–135.

6 (a) (1) In this section the following words have the meanings indicated.

7 **(2) “DESIGNATED PROTECTION AND ADVOCACY SYSTEMS**
8 **AGENCY” MEANS A PROTECTION AND ADVOCACY SYSTEMS AGENCY THAT IS**
9 **DESIGNATED AS AN INDEPENDENT ADVOCATE FOR INDIVIDUALS WITH**
10 **DISABILITIES UNDER THE FEDERAL DEVELOPMENTAL DISABILITIES ACT.**

11 **[(2)] (3)** “Nursing facility” has the meaning stated in § 15–132(a)(11)
12 of this subtitle.

13 **[(3)] (4)** “Resident” means an individual receiving long–term care in
14 a nursing facility.

15 (b) (1) A social worker shall provide to each resident information that:

16 (i) Explains the availability of services under home– or
17 community–based waiver programs in the State that could enable the resident to live
18 in the community;

19 (ii) Explains that if the resident’s care is partially or fully
20 reimbursed by the Program, the resident may be able to receive long–term care
21 services in the community instead of in the nursing facility;

22 (iii) Provides information regarding how to obtain case
23 management services or evaluation services related to home– and community–based
24 waiver programs or other options for receiving long–term care services in the
25 community;

26 (iv) If written, is in large, easily legible type and in formats
27 accessible to the resident; and

28 (v) Includes a list of legal, advocacy, and government agency
29 resources.

30 (2) The Department, in consultation with the State agencies that
31 implement the home– and community–based services programs, shall prepare,
32 distribute, and update as necessary the information required under paragraph (1) of
33 this subsection.

1 (3) The information required under paragraph (1) of this subsection
2 shall be made available to the resident:

3 (i) Upon admission [or] AND discharge of the resident; and

4 (ii) When the resident indicates a preference to live in the
5 community, either during the resident's quarterly assessment or at any other time.

6 (4) The social worker shall request that the resident sign an
7 acknowledgment of receipt of the information provided by the social worker that shall
8 be kept in the resident's medical record.

9 (c) If a resident indicates an interest in or a preference for living in the
10 community, the nursing facility shall refer the resident to the Department, or the
11 Department's designee, for further assistance.

12 (d) The Department, or the Department's designee, shall review the
13 quarterly assessments submitted to the Center for Medicare and Medicaid Services of
14 the U.S. Department of Health and Human Services by each nursing facility that
15 participates in the Program to identify individuals indicating a preference to live in
16 the community.

17 (e) If a resident who would qualify for home- and community-based waiver
18 services under § 15-137 of this subtitle indicates an interest or preference for living in
19 the community, the Department, or the Department's designee, shall provide the
20 resident with:

21 (1) Additional information regarding home- and community-based
22 services, including services available under a medical assistance waiver and their
23 right to access services under § 15-137 of this subtitle, ~~WITHIN 10 DAYS OF THE~~
24 ~~RESIDENT'S INITIAL INQUIRY~~; and

25 (2) Assistance in:

26 (i) Completing any application forms or process, as needed, ~~;~~
27 ~~WITHIN 10 DAYS OF THE RESIDENT'S INITIAL INQUIRY~~; and

28 (ii) Moving from a nursing facility to a community-based
29 setting appropriate to the residents' needs and expressed wishes ~~WITHIN 25 DAYS OF~~
30 ~~THE RESIDENT'S INITIAL INQUIRY OR WITH REASONABLE PROMPTNESS~~.

31 (f) (1) Subject to paragraph (3) of this subsection, employees or
32 representatives of DESIGNATED protection and advocacy SYSTEMS agencies and of
33 CERTIFIED centers for independent living shall have reasonable and unaccompanied
34 access to residents of public or private nursing facilities in the State that receive
35 reimbursement under the Program for the purpose of providing information, training,

1 and referral to programs and services addressing the needs of people with disabilities,
 2 including participation in programs that would enable individuals with disabilities to
 3 live outside the nursing facility.

4 (2) Employees or representatives of **DESIGNATED** protection and
 5 advocacy **SYSTEMS** agencies and of **CERTIFIED** centers for independent living shall
 6 maintain the confidentiality of the residents and may not disclose the information
 7 provided to **OR BY** a resident, except with the express consent of the resident or the
 8 resident's legal guardian or health care representative.

9 (3) Public or private nursing facilities may require the employees or
 10 representatives of **DESIGNATED** protection and advocacy **SYSTEMS** agencies and of
 11 **CERTIFIED** centers for independent living to provide proof of their employment before
 12 authorizing the access required under paragraph (1) of this subsection.

22 ~~{(g)}~~ **(H)** On or before January 1 of each year, the Department, and the
 23 Department's designee, shall report to the Governor and the General Assembly, in
 24 accordance with § 2-1246 of the State Government Article, on:

25 (1) The Department's efforts to promote home- and community-based
 26 services;

27 (2) The number of nursing facility residents referred or identified
 28 under subsections (c) and (d) of this section in the previous year;

29 (3) The number of nursing facility residents who transitioned from
 30 nursing facilities to home- and community-based waiver services;

31 (4) Any obstacles the Department confronted in assisting nursing
 32 home residents to make the transition from a nursing facility to a community-based
 33 residence; and

34 (5) The Department's recommendations for removing the obstacles.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2010.
