3 FOR the purpose of exempting certain applicants for licensure as a certain social 4 worker or a certain social worker-clinical from certain requirements under 5 circumstances; requiring certain applicants to meet certain 6 requirements, hold certain licensure or registration, have passed certain 7 examinations, and have performed certain practice over a certain period of time; 8 repealing the requirement that the State Board of Social Work Examiners 9 waive certain examination requirements under certain circumstances; and generally relating to the licensure of out-of-state applicants for licensure as a 10 certified social worker or a certified social worker-clinical. 11

- 8 (3) Provide in a form prescribed by the Board, documentation of having completed 2 years as a licensee with supervised experience of at least 3,000 hours after receiving the master's degree with a minimum of 144 hours of periodic face—to—face supervision in the assessment, formulation of a diagnostic impression, and treatment of mental disorders and other conditions and the provision of psychotherapy under the terms and conditions that the Board determines by regulation.
 - (g) If an applicant who is licensed or registered to practice social work in another state has obtained 2 years of supervised experience under circumstances that are otherwise equivalent to those required under subsection (d) of this section, the Board may waive the supervision requirement.
