1 AN ACT concerning

Carroll County – Gaming

3 FOR the purpose of authorizing certain nonprofit organizations in Carroll County to conduct a gaming contest that is a card game, card tournament, or casino night; 4 $\mathbf{5}$ authorizing the county commissioners to issue a permit to conduct a gaming 6 contest; specifying certain conditions under which a permit holder may conduct 7 a gaming contest; restricting a permit holder from conducting more than a 8 certain number of gaming contests in a calendar year; specifying the purposes 9 for which certain proceeds may be used; specifying the time when a gaming 10 contest may be conducted; requiring a participant to use wagering tokens for wagering under certain conditions; prohibiting a permit holder from taking 11 12certain actions; requiring a permit holder to submit to the Sheriff's Office a 13certain financial report within a certain time; authorizing the county 14 commissioners to adopt certain regulations; imposing certain penalties; defining 15certain terms; and generally relating to card games, card tournaments, and casino nights in Carroll County. 16

1 (a) A person may not knowingly operate or attempt to operate A GAMING 2 CONTEST AS DEFINED IN § 13-906(C) OF THIS SUBTITLE OR A gaming event in 3 violation of this subtitle.

4 (b) A person who violates this section is guilty of a misdemeanor and on 5 conviction is subject to imprisonment not exceeding 1 year or a fine not exceeding 6 \$1,000 or both.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect8 July 1, 2010.
