# Article 19 – Comptroller

(a) (1) Except as provided in paragraph (2) of this subsection, each
county, municipal corporation, and taxing district in the State shall by the first day of
November after the close of the fiscal year file with the Department of Legislative
Services its financial report covering the full period of that fiscal year.

1 (2) (i) Each county, municipal corporation, or taxing district with a 2 population of more than 400,000 may by the first day of January after the close of the 3 fiscal year file with the Department of Legislative Services its financial report 4 covering the full period of that fiscal year.

5 (ii) Unless subparagraph (i) of this paragraph applies, Howard 6 County may by the first day of December after the close of the fiscal year file with the 7 Department of Legislative Services its financial report covering the full period of that 8 fiscal year.

9 (iii) Frederick County may by the first day of January after the 10 close of the fiscal year file with the Department of Legislative Services its financial 11 report covering the full period of that fiscal year.

12 (iv) QUEEN ANNE'S COUNTY MAY BY THE FIRST DAY OF 13 JANUARY AFTER THE CLOSE OF THE FISCAL YEAR FILE WITH THE DEPARTMENT 14 OF LEGISLATIVE SERVICES ITS FINANCIAL REPORT COVERING THE FULL 15 PERIOD OF THAT FISCAL YEAR.

16 (V) Wicomico County may by the first day of January after the 17 close of the fiscal year file with the Department of Legislative Services its financial 18 report covering the full period of that fiscal year.

19 (b) The reports required by subsection (a) of this section shall be:

20 (1) Properly filled in on the form or forms established by the 21 Department as provided in this subtitle; and

(2) (2) Verified by the chief executive officer of each county, municipalcorporation, and taxing district.
