- 3 FOR the purpose of altering the term of the members of the Kent County Board of 4 Education; requiring the County Commissioners of Kent County to appoint a 5 certain individual to fill any vacancy on the Board under certain circumstances; 6 repealing certain provisions providing for the election of a certain candidate to 7 fill a certain vacancy on the Board; providing for the application of certain 8 provisions of this Act; requiring certain members of the Board to be elected in a 9 certain general election; providing for the termination of the terms of certain 10 elected members of the county board; making certain technical corrections; and generally relating to the terms of members and vacancies on the Kent County 11 Board of Education.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18
