# A BILL ENTITLED

1 AN ACT concerning

## 2 Campaign Finance Entities – Contribution Records and Reports

- 3 FOR the purpose of requiring the treasurer of a campaign finance entity, to the extent 4 practicable, to record certain information regarding an individual who makes  $\mathbf{5}$ contributions of a certain cumulative amount during a certain period of time to 6 the campaign finance entity; requiring the treasurer to include certain 7 information regarding contributors in the campaign finance report that the 8 treasurer of a campaign finance entity is required to file; providing for a delayed 9 effective date; and generally relating to the contribution records and reports of 10 campaign finance entities.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:

20 (a) (1) The treasurer of a campaign finance entity shall keep a detailed 21 and accurate account book of all assets received, expenditures made, and obligations 22 incurred by or on behalf of the entity.

23 (2) Except as provided in § 13–240 of this subtitle, as to each asset 24 received or expenditure made, the account book shall state:

7 8 9 10 11	(3) TO THE EXTENT PRACTICABLE, THE TREASURER OF A CAMPAIGN FINANCE ENTITY SHALL RECORD THE OCCUPATION AND EMPLOYER OF AN INDIVIDUAL WHO MAKES CONTRIBUTIONS TO THE CAMPAIGN FINANCE ENTITY IN A CUMULATIVE AMOUNT OF \$200 OR MORE DURING A CALENDAR YEAR.
12 13	[(3)] (4) Each expenditure made from a campaign account shall be supported by a receipt.
$14 \\ 15 \\ 16$	(b) The account books and related records of a campaign finance entity shall be preserved until 2 years after the campaign finance entity files a final campaign finance report under Subtitle 3 of this title.
