1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2008 – St. Mary’s County – St.**
3 **Mary’s College Amphitheater**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2008
5 to reduce the amount of a certain grant for the St. Mary’s College
6 Amphitheater; authorizing certain grants for the Cedar Lane Apartment
7 Renovations and the United States Colored Troops Memorial Monument; and
8 generally relating to amending the Maryland Consolidated Capital Bond Loan
9 of 2008 to alter certain grants.
