Kids First Express Lane Eligibility Act

FOR the purpose of requiring the Comptroller under certain circumstances to send information from a taxpaver's tax return to the Department of Health and Mental Hygiene for the purpose of determining eligibility of a certain dependent child for the Maryland Medical Assistance Program and the Maryland Children's Health Program; repealing a certain provision of law that requires the Comptroller to send certain applications and enrollment materials to a taxpayer under certain circumstances; authorizing the Comptroller under certain circumstances to send information from a taxpayer's tax return to the Department: repealing a certain provision of law that prohibits the Comptroller from sending a notice or information with certain applications and enrollment instructions; requiring the Department, based on certain information, to send certain applications and enrollment instructions to a taxpayer; requiring the Comptroller and the Secretary of Health and Mental Hygiene to enter into an interagency agreement that allows the sharing of information from the income tax return of a taxpayer for a certain purpose; requiring the Comptroller, in consultation with the Department of Health and Mental Hygiene, to provide a certain notice with the income tax return; requiring the Comptroller to provide a box on the income tax return for a certain purpose; prohibiting the Comptroller from sharing information with the Department if a taxpayer opts out fails to opt in; authorizing the Comptroller to disclose tax information from the income tax return to the Department in accordance with certain federal and State laws; extending the tax years for which the Comptroller must send certain applications and enrollment materials to a taxpayer under certain
