A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2008 – Baltimore City**
3 **– Roberta’s House**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2008
5 to extend the deadline by which the Board of Directors of Roberta’s House, Inc.
6 must present evidence that a certain match will be provided.

7 BY repealing and reenacting, with amendments,
8 Chapter 336 of the Acts of the General Assembly of 2008
9 Section 1(3) Item ZA01(AA) and ZA02(X)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Chapter 336 of the Acts of 2008**

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That:

15 (3) ZA01 LOCAL SENATE INITIATIVES

16 (AA) Roberta’s House. Provide a grant equal to the lesser of (i)
17 \$50,000 or (ii) the amount of the matching fund provided, to
18 the Board of Directors of Roberta’s House, Inc. for the
19 acquisition, planning, design, renovation, construction,
20 reconstruction, repair, and capital equipping of Roberta’s
21 House, located in Baltimore City. Notwithstanding Section
22 1(5) of this Act, the matching fund may consist of real
23 property, in kind contributions, or funds expended prior to the
24 effective date of this Act **AND THE GRANTEE MUST PRESENT**
25 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED**

9 1(5) of this Act, the matching fund may consist of real
10 property, in kind contributions, or funds expended prior to the
11 effective date of this Act **AND THE GRANTEE MUST PRESENT**
12 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED**
13 **BY JUNE 1, 2012** (Baltimore City) 250,000

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 June 1, 2010.
