## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2008 and 2009 – Montgomery**  
3 **County – Imagination Stage**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2008  
5 and 2009 to alter the matching fund requirement of certain grants to include  
6 funds expended on or after a certain date and extending the deadline under  
7 certain grants to present evidence that a certain matching fund will be  
8 provided.

9 BY repealing and reenacting, with amendments,  
10 Chapter 336 of the Acts of the General Assembly of 2008  
11 Section 1(3) Item ZA02(AV)

12 BY repealing and reenacting, with amendments,  
13 Chapter 485 of the Acts of the General Assembly of 2009  
14 Section 1(3) Item ZA02(AH) and Item ZA03(AM)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That the Laws of Maryland read as follows:

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

22 \$200,000 or (ii) the amount of the matching fund provided, to
