A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Montgomery County**
3 **– Our House Youth Home**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to extend the date by which the Board of Directors of Our House Youth Home,
6 Inc. must present evidence that a certain matching fund will be provided.

7 BY repealing and reenacting, with amendments,
8 Chapter 46 of the Acts of the General Assembly of 2006, as amended by Chapter
9 219 of the Acts of the General Assembly of 2008 and Chapter 707 of the
10 Acts of the General Assembly of 2009
11 Section 1(3) Item ZA01(CP) and Item ZA02(AZ)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Chapter 46 of the Acts of 2006, as amended by Chapter 219 of the Acts of 2008**
15 **and Chapter 707 of the Acts of 2009**

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

 the construction and capital equipping of a new dormitory at
 Our House Youth Home, located in Olney, subject to a
 requirement that the grantee grant and convey a historic
 easement to the Maryland Historical Trust. Notwithstanding
 Section 1(5) of this Act, the grantee has until June 1, **[2010]**
2012, to present evidence that a matching fund will be
 provided (Montgomery County) 250,000

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 June 1, 2010.
