(k) (1) 4 **(4)** A license may be obtained by any local unit of a nationwide bona 5 fide nonprofit organization or club composed solely of members who served in the 6 armed forces of the United States in any war in which the United States has engaged 7 and: 8 Has held a charter from a national veterans' organization for (i) 9 a period of not less than 5 years prior to the time of making application for the license; 10 (ii) Has a bona fide membership of not less than [125] 50 11 persons and dues of not less than \$5 per year per person; 12 Operates solely for the use of its own members and their guests when accompanied by such members; and 13 14 Meets in a clubhouse principally used for no other purpose.
