## CHAPTER \_\_\_\_\_

1 AN ACT concerning

### 2 **Public Safety – Board of Boiler Rules – Membership**

3 FOR the purpose of altering the membership of the Board of Boiler Rules in the  
4 Division of Labor and Industry in the Department of Labor, Licensing, and  
5 Regulation to include a representative of owners of agricultural, model, or  
6 historical steam engine equipment rather than a representative of owners and  
7 users of heating boilers.

8 BY repealing and reenacting, without amendments,  
9 Article – Public Safety  
10 Section 12-904(a)  
11 Annotated Code of Maryland  
12 (2003 Volume and 2009 Supplement)

13 BY repealing and reenacting, with amendments,  
14 Article – Public Safety  
15 Section 12-904(b)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

### 20 **Article – Public Safety**

2 (a) There is a Board of Boiler Rules in the Division of Labor and Industry in  
3 the Department of Labor, Licensing, and Regulation.

4 (b) (1) The Board consists of the following 10 members:

5 (i) as an ex officio member, the Commissioner; and

6 (ii) nine members appointed by the Governor with the advice of  
7 the Secretary and with the advice and consent of the Senate.

8 (2) Of the nine appointed members of the Board:

9 (i) one shall be a representative of owners and users of power  
10 boilers;

11 (ii) one shall be a representative of owners [and users of heating  
12 boilers] **OF AGRICULTURAL, MODEL, OR HISTORICAL STEAM ENGINE**  
13 **EQUIPMENT;**

14 (iii) one shall be a representative of owners and users of pressure  
15 vessels;

16 (iv) one shall be a representative of manufacturers or  
17 assemblers of boilers or pressure vessels;

18 (v) one shall be a representative of an insurer authorized to  
19 insure boilers or pressure vessels;

20 (vi) one shall be a mechanical engineer on the faculty of a  
21 recognized engineering college in the State;

22 (vii) one shall be a stationary engineer;

23 (viii) one shall be a professional engineer with boiler or pressure  
24 vessel experience; and

25 (ix) one shall be a consumer member.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
27 October 1, 2010.
