A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Issuance of Temporary Registration Plates by Dealers –**
3 **Transmission of Information and Record Keeping**

4 FOR the purpose of requiring a dealer who issues a temporary registration plate for a
5 vehicle to electronically transmit certain information to the Motor Vehicle
6 Administration in the format required by the Administration; reducing the
7 period of time during which a dealer is required to keep certain temporary
8 registration plate records; and generally relating to the temporary registration
9 of motor vehicles.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Transportation**

18 13–602.

19 (a) (1) Subject to the provisions of this part, a licensed dealer may issue
20 one temporary registration plate for a vehicle to the person who buys the vehicle from
21 the dealer, whether or not the vehicle is to be registered in this State.

22 (2) The dealer may not issue more than one temporary registration for
23 any vehicle.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 (b) Before a temporary registration plate may be issued for a vehicle, the
2 buyer of the vehicle shall complete and deliver to the dealer a temporary registration
3 plate application, on the form that the Administration requires.

4 (c) On the same day that a dealer issues a temporary registration plate for a
5 vehicle, the dealer shall [send]:

6 (1) **SEND** to the Administration a copy of the temporary registration
7 plate application completed by the buyer of the vehicle; **AND**

8 (2) **ELECTRONICALLY TRANSMIT TO THE ADMINISTRATION, IN**
9 **THE FORMAT THAT THE ADMINISTRATION REQUIRES, THE VEHICLE, OWNER,**
10 **INSURANCE, AND TEMPORARY REGISTRATION INFORMATION CONTAINED ON**
11 **THE TEMPORARY REGISTRATION PLATE APPLICATION.**

13 (a) Each dealer who has applied for temporary registration plates under §
14 13-601 of this subtitle shall keep a [permanent] record **FOR 3 YEARS** of all temporary
15 registration plates delivered to the dealer.

16 (b) Each dealer who has applied for temporary registration plates under §
17 13-601 of this subtitle shall keep a [permanent] record **FOR 3 YEARS** of all temporary
18 registration plates issued by the dealer.

19 (c) Each dealer who has applied for temporary registration plates under §
20 13-601 of this subtitle shall keep a [permanent] record **FOR 3 YEARS** of any other
21 relevant information that the Administration requires.

22 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect
23 October 1, 2010.
