4 (a) Except as provided in subsection (d) of this section, this subtitle applies to 5 all procurements by a designated procurement unit.

6 (b) This subsection does not apply to procurements subject to Subtitle 1 of 7 this title.

8 (c) A designated procurement unit shall structure its procurement 9 procedures to achieve a minimum of 10% of the unit's total dollar value of goods, 10 supplies, services, maintenance, construction, construction-related services, AND 11 architectural [service,] and engineering service contracts to be made directly to small 12 businesses.

13 (d) The total dollar value of procurements by a designated procurement unit 14 does not include the value of contracts to which this section does not apply because of 15 a conflict with federal law.

(a) The Department of General Services shall adopt regulations to establish
procedures for compiling and maintaining a comprehensive bidder's list of qualified
small businesses that shall be posted on the Department's website.

20 (b) Each designated procurement unit shall ensure compliance with the 21 regulations set forth in subsection (a) of this section.

14-504.

(a) Any procurement by a designated procurement unit of goods, supplies,
 services, maintenance, construction, construction-related services, architectural
 services, and engineering services shall be eligible for designation for the small
 business reserve.

(b) A solicitation for procurement that has been designated for a small
business reserve shall be published in the same manner as required for an invitation
for bids as set forth in § 13–103(c) of this article.

30 (c) The procurement officer of a designated procurement unit shall award a
 31 procurement contract designated for a small business reserve to the small business
 32 that submits a responsive bid that:

price; or is the bid or proposal most favorable to the State within the small (3)business reserve. 14 - 505.(a) Within 90 days after the end of each fiscal year, each designated procurement unit shall submit a report on the operation and effectiveness of the Small Business Reserve Program that complies with subsection (d)(2) of this section to the Board of Public Works. (b)Within 60 days after receipt of all reports required under subsection (a) of this section, the Board of Public Works shall compile the information and report on the operation and effectiveness of the entire Small Business Reserve Program to the Legislative Policy Committee, subject to § 2–1246 of the State Government Article. Within 60 days after the enactment of the budget bill by the General (c) Assembly, each designated procurement unit shall submit a report to the Governor's Office of Minority Affairs that complies with the reporting requirements set forth in COMAR 21.11.01.06. Within 90 days after the end of each fiscal year, each unit shall (d) (1)submit a report to the Governor's Office of Minority Affairs that complies with the requirements of paragraph (2) of this subsection. (2)For the preceding fiscal year, the report shall: (i) state the total number and the dollar value of payments the unit made to small businesses under designated small business reserve contracts; state the total number and the dollar value of payments the (ii) unit made to small businesses under nondesignated small business reserve contracts, including purchase card procurements: (iii) state the total dollar value of payments the unit made under procurement contracts; and contain other such information as required by the (iv) Governor's Office of Minority Affairs. (e) On or before December 31 of each year, the Governor's Office of Minority Affairs shall submit to the Board of Public Works and, subject to § 2–1246 of the State Government Article, to the Legislative Policy Committee a report summarizing the information the Office receives under subsection (b) of this section.

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 3 October 1, 2004. It shall remain effective for a period of [6] 12 years and, at the end of 4 September 30, [2010] 2016, with no further action required by the General Assembly, 5 this Act, and any regulations adopted under the provisions of this Act, shall be 6 abrogated and of no further force and effect.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectJuly 1, 2010.
