3 FOR the purpose of altering certain provisions of law so as to require the Governor to 4 appoint directly the Director of the Maryland Emergency Management Agency $\mathbf{5}$ (MEMA); requiring the Director of MEMA to be responsible to the Governor for 6 carrying out the State emergency management program, to develop certain 7 mutual aid agreements without a certain approval, and to employ personnel in 8 a certain manner that is not subject to a certain authority; and generally 9 relating to the Director of the Maryland Emergency Management Agency.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15MARYLAND, That the Laws of Maryland read as follows: 16
