23	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF							
24	MARYLAND, That the Laws of Maryland read as follows:

- 2 Except as otherwise provided in this title, the provisions of this subtitle apply to
- 3 any scholarship, grant, [or] loan, OR OTHER STUDENT FINANCIAL ASSISTANCE
- 4 awarded [under this title] BY THE OFFICE.
- 5 18–103.
- A scholarship, grant, [or] loan, OR OTHER STUDENT FINANCIAL ASSISTANCE
- 7 [issued under this title] AWARDED BY THE OFFICE may be used at any public or
- 8 private institution of higher education in this State that possesses a certificate of
- 9 approval from the [Maryland Higher Education] Commission.

- 11 (a) If, during an academic year, a student who is receiving any STUDENT
- 12 FINANCIAL ASSISTANCE award [under this title] withdraws from the institution at
- 13 which the award is used or otherwise fails to remain eligible for the award, the
- institution shall make a pro rata refund to the Office or other donor on the same terms
- 15 that it makes refunds to students.
- 16 (b) Any refund may be reawarded on an interim basis under this title until
- 17 the end of the academic year. Any requirement of an examination is waived for the
- 18 recipient of an interim award.

- 20 (a) (1) Each year, money for each [award] STUDENT FINANCIAL
- 21 ASSISTANCE program [under this title] ADMINISTERED BY THE OFFICE shall be
- 22 included in the State budget.
- 23 (2) Each year, the Governor shall include in the State budget at least
- 24 80 percent of the funds appropriated in the prior fiscal year for need-based programs
- 25 as provided in §§ 18–301, 18–706(f), 18–1401, 18–1501, and 18–2601 of this title.
- 26 (b) (1) Except as otherwise provided in this title, money appropriated
- 27 under this title that is not used by the end of the fiscal year may not revert to the
- 28 State Treasury.
- 29 (2) All money retained under paragraph (1) of this subsection shall be
- 30 used to make awards to students during subsequent fiscal years as provided in
- 31 §§ 18–301, 18–601, 18–604, 18–706(f), 18–1401, 18–14A–01, 18–1501, and 18–2601 of
- 32 this title and may not be used for administrative expenses.

Any college student or other individual, who is under 18 years old and is eligible for or is receiving benefits from any State scholarship, loan, tuition grant, remission of fixed charges, fellowship, [or] federal or State student loan program [under this title], OR ANY OTHER STUDENT FINANCIAL ASSISTANCE:

- 5 (1) May execute notes, contracts, or agreements necessary to obtain 6 these benefits in the same manner and with the same effect as though he were 18 7 years old; and
- 8 (2) May not assert the disability of infancy as a defense in any action 9 brought against him with respect to these benefits.

- 11 (a) The Office shall review and investigate each bond given by a recipient of 12 a scholarship.
- 13 (b) If the Office determines that any recipient has failed or refused to comply
 14 with the conditions of the bond, the Office may refer the matter to the Attorney
 15 General, who shall do anything necessary and proper to enforce the bond.
- 16 (c) The Attorney General shall account for any money received from enforcement of a bond and the money shall revert to the State Treasury.]

- 19 Any student attending a public institution of higher education who is not 20 a resident of this State and who is enrolled in an education course or program leading 21to an occupation as a licensed registered nurse or a licensed practical nurse shall pay 22only the tuition fees and other mandatory fees payable by a resident of this State if the 23 student furnishes a [surety bond or] promissory note to this State, with security satisfactory to the [Maryland Higher Education] Commission, that, on completion of 2425 the education course or program, the student will work in this State for at least 4 26 years as a licensed registered nurse or a licensed practical nurse in a hospital or 27 related institution, as defined in § 19–301 of the Health – General Article.

 ASSISTANCE awarded [under this title] BY THE OFFICE, each recipient shall sign a
 statement pledging to remain drug free. The Commission shall determine the contents
 of the drug free statement.

- 34 (a) Except as otherwise provided in this title, repayment obligations incurred 35 by recipients of student financial assistance [, scholarships, grants, or loans]

- administered by the [Commission under this title] **OFFICE** shall be calculated at an
- 2 interest rate equal to and matching the interest rate established by the United States
- 3 Department of Education for the Federal Stafford Loan on the first day of July of each
- 4 year, with interest not accruing prior to notification to the Commission of a recipient's
- 5 graduation or termination from an institution of higher education.
- 6 (b) A recipient shall commence repayment obligations [incurred under this 7 title] upon graduation or termination from an institution of higher education.

- [The] SUBJECT TO RULES AND REGULATIONS ADOPTED BY THE 7 8 COMMISSION, THE Office shall grant a deferment from the service obligation component of [a scholarship] STUDENT FINANCIAL ASSISTANCE awarded under this 9 title to: 10
- 11 (1) An individual who has been assigned military duty outside of the 12 State; or
- 13 **(2)** The spouse of an individual who has been assigned military duty 14 outside of the State.
