BY repealing and reenacting, with amendments, Article – Environment Section 7–211 through 7–214 Annotated Code of Maryland (2007 Replacement Volume and 2009 Supplement) BY repealing and reenacting, without amendments, Article – Environment Section 7–215 Annotated Code of Maryland (2007 Replacement Volume and 2009 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- Of the 13 members, 3 shall be public members appointed by the 1 2 Governor with the advice and consent of the Senate. 3 A public member may not be an individual who otherwise qualifies for membership under subsection (a)(2) of this section. 4 5 (c) (1) The term of a member is [6]10 years. 6 Except for an ex officio member, the terms of members are 7 staggered as required by the terms provided for members of the Council on July 1, 1982. [The terms of those members end as follows: 8 9 (i) 2 public members in 1982; 10 The member from the Department of Labor, Licensing, and Regulation, Division of Labor and Industry in 1984; 11 12 (iii) The members from the State Department of Agriculture and the University of Maryland in 1985; 13 14 The members from the Department of Natural Resources, the business of resource recovery, and the State Fire Marshal's designee in 1986; and 15 16 The members from the industry that generates hazardous 17 substances, the hazardous substance disposal and management industry, the low-level nuclear waste management industry, and the industry that generates 18 low-level nuclear waste and 1 public member in 1987. 19 20 (3)At the end of a term, a member continues to serve until a successor 21is appointed and qualifies. 22 A member who is appointed after a term has begun serves only for **(4)** 23 the rest of the term and until a successor is appointed and qualifies. 247-213. 25 From among the public members, the Council [annually] shall elect a 26 chairperson. 27 7-214.
