- 10 (a) On or before December 15 of the 2nd year before the evaluation date of a governmental activity or unit, the Legislative Policy Committee, based on a preliminary evaluation, may waive as unnecessary the evaluation required under this section.

- SECTION 2. AND BE IT FURTHER ENACTED, That on or before October 1, 2011, the State Board of Examiners of Landscape Architects, in conjunction with the Department of Labor, Licensing, and Regulation, shall submit a report to the Senate Education, Health, and Environmental Affairs Committee and the House Economic Matters Committee, in accordance with § 2–1246 of the State Government Article, on its consideration of:
- 26 (1) instituting a continuing education requirement for landscape 27 architects; and
- 28 (2) allowing individuals who have a college degree in a field related to landscape architecture to sit for the licensing examination under the academic option as described in § 9–303 of the Business Occupations and Professions Article.
