A BILL ENTITLED

1 AN ACT concerning

Prince George's County – Alcoholic Beverages – Class B–AE (Arts and Entertainment) License

- 4 FOR the purpose of authorizing the Board of License Commissioners for Prince $\mathbf{5}$ George's County to issue a Class B-AE (arts and entertainment) beer, wine and 6 liquor license; specifying that the license may be issued only to an 7 establishment in a certain arts and entertainment district as approved by the 8 City Council; specifying that the license may be issued for consumption of 9 alcoholic beverages on the licensed premises only; prohibiting a person from 10 holding more than a certain number of licenses; providing for an annual license fee: requiring the Board of License Commissioners to adopt certain regulations: 11 12limiting the number of licenses that the Board of License Commissioners may 13 issue; specifying that the license is exempt from a certain restriction; and generally relating to alcoholic beverages licenses in Prince George's County. 14
