22 23 24 25	(ii) Subject to subparagraphs (iii) and (iv) of this paragraph, the Board of License Commissioners may issue one Class 6 pub-brewery license or one Class 7 micro-brewery license, but not both, to a person that holds not more than three Class B beer, wine and liquor licenses.
