(a) There is a Class 7 micro-brewery (on- and off-sale) license. (d) (1)The on-sale privilege authorizes the holder, each calendar year, to sell at retail up to 4,000 barrels of beer brewed under this license to customers for consumption on the licensed premises. The off-sale privilege authorizes the holder to sell and deliver beer (2)brewed under this license to: (i) Any wholesaler licensed under this article to sell beer in this State; or (ii) Any person who is located in a state other than Maryland who is authorized under the laws of that state to receive brewed beverages. (3)(i) This paragraph applies only in: 1. Allegany County; 2. The City of Annapolis; 3. Anne Arundel County; 4. Baltimore City; 5. Baltimore County; 6. Calvert County; 7. Carroll County; 8. Charles County;
