12	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13	MARYLAND, That the Laws of Maryland read as follows:
14	Article – Business Regulation
15	18–101.

- 16 (a) (1) This section does not apply to the laws that relate to the sale of 17 alcoholic beverages.
- 18 (2) This section does not apply in Wicomico County.
- (b) Subject to this section and § 3–704 of the Labor and Employment Article,
  a retail or wholesale establishment may do business on Sunday.
- 21 (c) Notwithstanding an agreement to the contrary between a merchant and 22 landlord:

1 (1) the landlord may not directly or indirectly require the merchant to 2 open the merchant's place of business on Sunday; and

3 (2) a landlord may not directly or indirectly cancel or refuse to renew 4 the merchant's lease because the merchant refuses to open the merchant's place of 5 business on Sunday.

6 (d) Except in Howard, Montgomery, and Prince George's counties, and 7 except as provided in subsection (g) of this section, a new or used car dealer may not 8 sell, barter, deliver, give away, show, or offer for sale a motor vehicle or certificate of 9 title for a motor vehicle on Sunday.

10 (e) In Anne Arundel County, a dealer may sell, barter, deliver, give away, 11 show, or offer for sale on Sunday a new or used camping trailer, mobile home, or travel 12 trailer, as those terms are defined in Title 11 of the Transportation Article.

13 (f) A new or used car dealer who violates subsection (d) of this section is 14 guilty of a misdemeanor and, on conviction, is subject to a fine not exceeding \$10,000.

15 (g) In ANNE ARUNDEL COUNTY AND Worcester County, a dealer may sell, 16 barter, deliver, give away, show, or offer for sale a motorcycle, as defined in § 11–136 17 of the Transportation Article, or certificate of title for a motorcycle on Sunday.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect19 June 1, 2010.
