1 AN ACT concerning

2 **Criminal Procedure – Sexual Offenders – Lifetime Supervision**

3 FOR the purpose of repealing the requirement that the Maryland Parole Commission
4 administer extended sexual offender parole supervision; adding certain
5 hearings related to lifetime sexual offender supervision to the list of subsequent
6 proceedings for which the State’s Attorney is required to provide a certain notice
7 to a certain victim or victim’s representative; altering certain provisions relating
8 to extended sexual offender supervision of certain offenders; altering the term
9 for certain extended sexual offender supervision; requiring a sentence for
10 certain persons to include a term of lifetime sexual offender supervision;
11 authorizing a sentence for certain persons to include a term of lifetime sexual
12 offender supervision; altering the term of lifetime sexual offender supervision;
13 establishing that lifetime sexual offender supervision is imposed on a defendant
14 for a crime committed on or after a certain date; requiring a certain sentencing
15 court to impose certain conditions of lifetime sexual offender supervision and to
16 advise certain persons of the conditions of lifetime sexual offender supervision;
17 requiring the sentencing court to order a presentence investigation under
18 certain circumstances; requiring the sentencing court to order a certain risk
19 assessment under certain circumstances; authorizing a certain sentencing court
20 to adjust certain conditions of lifetime sexual offender supervision under certain

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 26 MARYLAND, That the Laws of Maryland read as follows:

27 **Article – Correctional Services**

28 7–206.

29 The Commission shall:

30 (1) evaluate information on the activities of parolees that the Division
 31 of Parole and Probation reports;

32 (2) issue warrants or delegate to the Director of the Division of Parole
 33 and Probation the authority to issue warrants to retake parolees who are charged with
 34 violating a condition of parole;

35 (3) review and make recommendations to the Governor:

36 (i) concerning parole of an inmate under a sentence of life
 37 imprisonment; and

1 (ii) if requested by the Governor, concerning a pardon,
2 commutation of sentence, or other clemency;

3 (4) establish and modify general policy governing the conduct of
4 parolees; AND

5 (5) arrange for psychiatric or psychological examination of applicants
6 for parole whenever the Commission believes that an examination will better enable it
7 to decide on the advisability of parole and include the expense for the examination in
8 its annual budget[; and

9 (6) administer extended sexual offender parole supervision under Title
10 11, Subtitle 7 of the Criminal Procedure Article].

13 (a) In this section, “subsequent proceeding” includes:

14 (1) a sentence review under § 8–102 of this article;

15 (2) a hearing on a request to have a sentence modified or vacated
16 under the Maryland Rules;

17 (3) in a juvenile delinquency proceeding, a review of a commitment
18 order or other disposition under the Maryland Rules;

19 (4) an appeal to the Court of Special Appeals;

20 (5) an appeal to the Court of Appeals; [and]

21 (6) A HEARING ON AN ADJUSTMENT OF SPECIAL CONDITIONS OF
22 LIFETIME SEXUAL OFFENDER SUPERVISION UNDER § 11–723 OF THIS TITLE OR
23 A HEARING ON A VIOLATION OF SPECIAL CONDITIONS OF LIFETIME SEXUAL
24 OFFENDER SUPERVISION OR A PETITION FOR DISCHARGE FROM SPECIAL
25 CONDITIONS OF LIFETIME SEXUAL OFFENDER SUPERVISION UNDER § 11–724 OF
26 THIS TITLE; AND

27 (7) any other postsentencing court proceeding.

28 (b) Following conviction or adjudication and sentencing or disposition of a
29 defendant or child respondent, the State’s Attorney shall notify the victim or victim’s
30 representative of a subsequent proceeding in accordance with § 11–104(e) of this title
31 if:

1 (1) before the State's Attorney distributes notification request forms
2 under § 11-104(c) of this title, the victim or victim's representative submitted to the
3 State's Attorney a written request to be notified of subsequent proceedings; or

4 (2) after the State's Attorney distributes notification request forms
5 under § 11-104(c) of this title, the victim or victim's representative submits a
6 notification request form in accordance with § 11-104(d) of this title.

7 (c) (1) The State's Attorney's office shall:

8 (i) notify the victim or victim's representative of all appeals to
9 the Court of Special Appeals and the Court of Appeals; and

10 (ii) send an information copy of the notification to the office of
11 the Attorney General.

12 (2) After the initial notification to the victim or victim's representative
13 or receipt of a notification request form, as defined in § 11-104 of this title, the office of
14 the Attorney General shall:

15 (i) notify the victim or victim's representative of each
16 subsequent date pertinent to the appeal, including dates of hearings, postponements,
17 and decisions of the appellate courts; and

18 (ii) send an information copy of the notification to the State's
19 Attorney's office.

20 (d) A notice sent under this section shall include the date, the time, the
21 location, and a brief description of the subsequent proceeding.

23 (a) In this subtitle the following words have the meanings indicated.

24 (b) "Board" means the Sexual Offender Advisory Board.

25 (c) "Child sexual offender" means a person who:

26 (1) has been convicted of violating § 3-602 of the Criminal Law
27 Article;

28 (2) has been convicted of violating any of the provisions of the rape or
29 sexual offense statutes under §§ 3-303 through 3-307 of the Criminal Law Article for
30 a crime involving a child under the age of 15 years;

1 (3) has been convicted of violating the fourth degree sexual offense
2 statute under § 3–308 of the Criminal Law Article for a crime involving a child under
3 the age of 15 years and has been ordered by the court to register under this subtitle;

4 (4) has been convicted in another state or in a federal, military, or
5 Native American tribal court of a crime that, if committed in this State, would
6 constitute one of the crimes listed in items (1) and (2) of this subsection; or

7 (5) (i) has been adjudicated delinquent for an act involving a
8 victim under the age of 15 years that would constitute a violation of § 3–303, § 3–304,
9 § 3–305, or § 3–306 of the Criminal Law Article if committed by an adult; and

10 (ii) meets the requirements for registration under § 11–704(c) of
11 this subtitle.

12 (d) [“Commission” means the Maryland Parole Commission.

13 (e)] “Employment” means an occupation, job, or vocation that is full time or
14 part time for a period exceeding 14 days or for an aggregate period exceeding 30 days
15 during a calendar year, whether financially compensated, volunteered, or for the
16 purpose of government or educational benefit.

17 [(f) “Extended parole supervision offender” means a person who:

18 (1) is a sexually violent predator;

19 (2) has been convicted of a violation of § 3–303, § 3–304, § 3–305, §
20 3–306(a)(1) or (2), or § 3–307(a)(1) or (2) of the Criminal Law Article;

21 (3) has been convicted of a violation of § 3–309, § 3–310, or § 3–311 of
22 the Criminal Law Article or an attempt to commit a violation of § 3–306(a)(1) or (2) of
23 the Criminal Law Article;

24 (4) has been convicted of a violation of § 3–602 of the Criminal Law
25 Article for commission of a sexual act involving penetration of a child under the age of
26 12 years; or

27 (5) has been convicted more than once of a crime as a child sexual
28 offender, an offender, or a sexually violent offender.]

29 [(g)] (E) “Local law enforcement unit” means the law enforcement unit in a
30 county that has been designated by resolution of the county governing body as the
31 primary law enforcement unit in the county.

32 [(h)] (F) “Offender” means a person who is ordered by a court to register
33 under this subtitle and who:

1 (1) has been convicted of violating § 3–503 of the Criminal Law
2 Article;

3 (2) has been convicted of violating § 3–502 of the Criminal Law Article
4 or the fourth degree sexual offense statute under § 3–308 of the Criminal Law Article,
5 if the victim is under the age of 18 years;

6 (3) has been convicted of the common law crime of false imprisonment,
7 if the victim is under the age of 18 years and the person is not the victim’s parent;

8 (4) has been convicted of a crime that involves soliciting a person
9 under the age of 18 years to engage in sexual conduct;

10 (5) has been convicted of violating the child pornography statute
11 under § 11–207 of the Criminal Law Article;

12 (6) has been convicted of violating any of the prostitution and related
13 crimes statutes under Title 11, Subtitle 3 of the Criminal Law Article if the intended
14 prostitute or victim is under the age of 18 years;

15 (7) has been convicted of a crime that involves conduct that by its
16 nature is a sexual offense against a person under the age of 18 years;

17 (8) has been convicted of an attempt to commit a crime listed in items
18 (1) through (7) of this subsection; or

19 (9) has been convicted in another state or in a federal, military, or
20 Native American tribal court of a crime that, if committed in this State, would
21 constitute one of the crimes listed in items (1) through (8) of this subsection.

22 **[(i)] (G)** (1) Except as otherwise provided in this subsection, “release”
23 means any type of release from the custody of a supervising authority.

24 (2) “Release” means:

25 (i) release on parole;

26 (ii) mandatory supervision release;

27 (iii) release from a correctional facility with no required period of
28 supervision;

29 (iv) work release;

30 (v) placement on home detention; and

1 (vi) the first instance of entry into the community that is part of
2 a supervising authority's graduated release program.

3 (3) "Release" does not include:

4 (i) an escape; or

5 (ii) leave that is granted on an emergency basis.

6 **[(j)] (H)** "Sexually violent offender" means a person who:

7 (1) has been convicted of a sexually violent offense;

8 (2) has been convicted of an attempt to commit a sexually violent
9 offense; or

10 (3) (i) has been adjudicated delinquent for an act involving a
11 victim 15 years of age or older that would constitute a violation of § 3-303, § 3-304, §
12 3-305, or § 3-306 of the Criminal Law Article if committed by an adult; and

13 (ii) meets the requirements for registration under § 11-704(c) of
14 this subtitle.

15 **[(k)] (I)** "Sexually violent offense" means:

16 (1) a violation of §§ 3-303 through 3-307 or §§ 3-309 through 3-312 of
17 the Criminal Law Article;

18 (2) assault with intent to commit rape in the first or second degree or
19 a sexual offense in the first or second degree as prohibited on or before September 30,
20 1996, under former Article 27, § 12 of the Code; or

21 (3) a crime committed in another state or in a federal, military, or
22 Native American tribal jurisdiction that, if committed in this State, would constitute
23 one of the crimes listed in item (1) or (2) of this subsection.

24 **[(l)] (J)** "Sexually violent predator" means:

25 (1) a person who:

26 (i) is convicted of a sexually violent offense; and

27 (ii) has been determined in accordance with this subtitle to be at
28 risk of committing another sexually violent offense; or

1 (2) a person who is or was required to register every 90 days for life
2 under the laws of another state or a federal, military, or Native American tribal
3 jurisdiction.

4 **[(m)] (K)** “Supervising authority” means:

5 (1) the Secretary, if the registrant is in the custody of a correctional
6 facility operated by the Department;

7 (2) the administrator of a local correctional facility, if the registrant,
8 including a participant in a home detention program, is in the custody of the local
9 correctional facility;

10 (3) the court that granted the probation or suspended sentence, except
11 as provided in item (12) of this subsection, if the registrant is granted probation before
12 judgment, probation after judgment, or a suspended sentence;

13 (4) the Director of the Patuxent Institution, if the registrant is in the
14 custody of the Patuxent Institution;

15 (5) the Secretary of Health and Mental Hygiene, if the registrant is in
16 the custody of a facility operated by the Department of Health and Mental Hygiene;

17 (6) the court in which the registrant was convicted, if the registrant’s
18 sentence does not include a term of imprisonment or if the sentence is modified to time
19 served;

20 (7) the Secretary, if the registrant is in the State under terms and
21 conditions of the Interstate Compact for Adult Offender Supervision, set forth in Title
22 6, Subtitle 2 of the Correctional Services Article, or the Interstate Corrections
23 Compact, set forth in Title 8, Subtitle 6 of the Correctional Services Article;

24 (8) the Secretary, if the registrant moves to this State and was
25 convicted in another state of a crime that would require the registrant to register if the
26 crime was committed in this State;

27 (9) the Secretary, if the registrant moves to this State from another
28 state where the registrant was required to register;

29 (10) the Secretary, if the registrant is convicted in a federal, military, or
30 Native American tribal court and is not under supervision by another supervising
31 authority;

32 (11) the Secretary, if the registrant is not a resident of this State and
33 has been convicted in another state or by a federal, military, or Native American tribal
34 court;

1 (12) the Director of Parole and Probation, if the registrant is under the
2 supervision of the Division of Parole and Probation; or

3 (13) the Secretary of Juvenile Services, if the registrant was a minor at
4 the time the act was committed for which registration is required.

5 [(n)] (L) "Transient" means a nonresident registrant who enters a county of
6 this State with the intent to be in the State or is in the State for a period exceeding 14
7 days or for an aggregate period exceeding 30 days during a calendar year for a purpose
8 other than employment or to attend an educational institution.

10 (a) Except where a term of natural life without the possibility of parole is
11 imposed, a sentence for [an extended parole supervision offender] **THE FOLLOWING**
12 **PERSONS** shall include a term of [extended] **LIFETIME** sexual offender [parole]
13 supervision:

14 (1) **A PERSON WHO IS A SEXUALLY VIOLENT PREDATOR;**

15 (2) **A PERSON WHO HAS BEEN CONVICTED OF A VIOLATION OF §**
16 **3-303, § 3-304, § 3-305, OR § 3-306(A)(1) OR (2), ~~OR § 3-307(A)(1) OR (2)~~ OF**
17 **THE CRIMINAL LAW ARTICLE;**

18 (3) **A PERSON WHO HAS BEEN CONVICTED OF A VIOLATION OF §**
19 **3-309, § 3-310, OR § 3-311 OF THE CRIMINAL LAW ARTICLE OR AN ATTEMPT TO**
20 **COMMIT A VIOLATION OF § 3-306(A)(1) OR (2) OF THE CRIMINAL LAW ARTICLE;**

21 (4) **A PERSON WHO HAS BEEN CONVICTED OF A VIOLATION OF §**
22 **3-602 OF THE CRIMINAL LAW ARTICLE FOR THE COMMISSION OF A SEXUAL ACT**
23 **INVOLVING PENETRATION OF A CHILD UNDER THE AGE OF 12 YEARS; AND**

24 (5) **A PERSON WHO HAS BEEN CONVICTED MORE THAN ONCE**
25 **ARISING OUT OF SEPARATE INCIDENTS OF A CRIME AS A CHILD SEXUAL**
26 **OFFENDER, AN OFFENDER, OR A SEXUALLY VIOLENT OFFENDER THAT**
27 **REQUIRES REGISTRATION UNDER THIS SUBTITLE.**

28 (B) **EXCEPT WHERE A TERM OF NATURAL LIFE WITHOUT THE**
29 **POSSIBILITY OF PAROLE IS IMPOSED, A SENTENCE FOR A VIOLATION OF §**
30 **3-307(A)(1) OR (2) MAY INCLUDE A TERM OF LIFETIME SEXUAL OFFENDER**
31 **SUPERVISION.**

15 (1) enter into and sign extended sexual offender parole supervision
16 agreements with registrants sentenced to supervision under § 11-723 of this subtitle

19 supervision violations; and

20 (3) impose sanctions for extended sexual offender parole supervision

26 **(B) A PERSON WHO VIOLATES ANY CONDITIONS IMPOSED UNDER §**

28 (1) FOR A FIRST OFFENSE, IS GUILTY OF A MISDEMEANOR AND ON
29 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 5 YEARS OR A
30 FINE NOT EXCEEDING \$5,000 OR BOTH; AND

1 **(2) FOR A SECOND OR SUBSEQUENT OFFENSE, IS GUILTY OF A**
2 **FELONY AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING**
3 **10 YEARS OR A FINE NOT EXCEEDING \$10,000 OR BOTH.**

4 **[(b)] (C)** Imprisonment for [an extended] A **LIFETIME** sexual offender
5 [parole] supervision violation is not subject to diminution credits.

6 **[(c)** Specific conditions of extended sexual offender parole supervision shall
7 commence upon release of the extended parole supervision offender from incarceration
8 or imposition of probation on the extended parole supervision offender and may
9 include:

10 (1) monitoring a registrant through global positioning satellite
11 tracking technology;

12 (2) where appropriate and feasible, restricting a registrant from living
13 in proximity to or loitering near schools, family day care centers, child care centers,
14 and other places primarily used by minors;

15 (3) restricting a registrant from obtaining employment or from
16 participating in an activity that would bring the registrant into contact with minors;

17 (4) requiring a registrant to participate in a certified sexual offender
18 treatment program;

19 (5) prohibiting a registrant from using illicit drugs or alcohol;

20 (6) authorizing parole agents to access the personal computer of a
21 registrant to check for material relating to sexual relations with minors;

22 (7) requiring a registrant to take regular polygraph examinations; and

23 (8) prohibiting a registrant from contacting specific individuals or
24 categories of individuals.]

25 **(D) (1) A VIOLATION OF SUBSECTION (A) OF THIS SECTION DOES NOT**
26 **DISCHARGE A PERSON FROM LIFETIME SEXUAL OFFENDER SUPERVISION.**

27 **(2) ON RELEASE FROM A SENTENCE IMPOSED UNDER**
28 **SUBSECTION (B) OF THIS SECTION, A PERSON REMAINS ON LIFETIME SEXUAL**
29 **OFFENDER SUPERVISION, SUBJECT TO THE ORIGINAL TERMS OF SUPERVISION,**
30 **UNTIL DISCHARGED UNDER SUBSECTION (G) OF THIS SECTION.**

31 **(E) DURING THE PERIOD OF LIFETIME SEXUAL OFFENDER**
32 **SUPERVISION, THE COURT MAY:**

1 **(1) ON WRITTEN CHARGES UNDER OATH OR ON VIOLATION OF A**
2 **CONDITION OF SUPERVISION, ISSUE A WARRANT REQUIRING THE PERSON**
3 **UNDER SUPERVISION TO BE BROUGHT OR TO APPEAR BEFORE THE JUDGE**
4 **ISSUING THE WARRANT:**

12 **(3) IF AT THE HEARING THE COURT FINDS THAT THE PERSON**
13 **VIOLATED A CONDITION OF SUPERVISION, IMPOSE A SENTENCE AS PRESCRIBED**

15 **(F) (1) THE JUDGE WHO ORIGINALLY IMPOSED THE LIFETIME**

18 (a) Under the supervision of the Division of Parole and Probation, a sexual
19 offender management team shall conduct [extended] **LIFETIME** sexual offender
20 [parole] supervision and the supervision of probation, parole, or mandatory release of
21 a [registrant] **PERSON** subject to [extended] **LIFETIME** sexual offender [parole]
22 supervision.

23 (b) A sexual offender management team:

24 (1) consists of:

25 (i) a specially trained parole **AND PROBATION** agent; and

29 (i) victim advocates **OR VICTIM SERVICE PROVIDERS WITH**

- 2 (iv) community leaders; [and]
- 3 (v) a [polygrapher] **POLYGRAPH EXAMINER WITH**
4 **RECOGNIZED EXPERTISE IN SEXUAL OFFENDER-SPECIFIC POLYGRAPH**
5 **EXAMINATION;**
- 6 **(VI) A LAW ENFORCEMENT OFFICER;**
- 7 **(VII) AN ASSISTANT STATE'S ATTORNEY;**
- 8 **(VIII) AN ASSISTANT PUBLIC DEFENDER; AND**
- 9 **(IX) A FOREIGN OR SIGN LANGUAGE INTERPRETER.**

10 (c) (1) A sexual offender management team shall submit a progress report
11 on each [registrant] **PERSON UNDER SUPERVISION** to the [Commission]
12 **SENTENCING COURT** once every 6 months.

13 (2) Unless disclosure of a report would be in violation of laws
14 regarding confidentiality of treatment records, a sexual offender management team
15 shall provide copies of each progress report to local law enforcement units of the
16 county in which the [registrant] **PERSON** resides [or where a sexual offender who is
