17 18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
19	Article - Transportation

21 22	(a) Without regard to the laws of this State relating to other State employees, the Secretary of Transportation may establish a human resources

management system for employees of the Department and its units. Any human

resources management system that the Secretary establishes under this section shall:



1	(1) Be based on merit;
$2\\3\\4$	(2) Include fair and equitable procedures for appointment, hiring promotion, layoff, removal, termination, redress of grievances, and reinstatement of employees; and
5 6 7 8	(3) Permit employees to participate in the pension and retirement systems for employees of the State of Maryland authorized under Division II of the State Personnel and Pensions Article or any other pension and retirement systems authorized by law.
9 10	(b) (1) In the exercise of the Secretary's powers under this section, the Secretary may:
11 12 13	(i) Create [and abolish any position other than positions specifically provided for in this article] ANY POSITION IN ACCORDANCE WITH STATE LAW; and
14 15 16	(ii) Subject to subsection (b-1) of this section, determine the qualifications, appointment, removal, tenure, terms of employment, and compensation of employees unless otherwise prohibited by law.
17 18 19	(2) The Secretary shall designate executive service employee and commission plan employee positions in the Human Resources Management System that:
20 21	(i) Must be filled without regard to political affiliation, belief, or opinion; or
22 23 24	(ii) In accordance with the criteria established under § 6–405(b) of the State Personnel and Pensions Article, may be filled with regard to political affiliation, belief, or opinion.
25 26 27	(3) On an annual basis, the Secretary shall report on the total number of positions designated under paragraph (2) of this subsection to the Governor and, in accordance with § 2–1246 of the State Government Article, to the General Assembly.
28 29	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2010.
