Any human resources management system that the Secretary establishes under this section shall:
5	(1) Be based on merit;
6 7 8	(2) Include fair and equitable procedures for appointment, hiring, promotion, layoff, removal, termination, redress of grievances, and reinstatement of employees; and
9 10 11 12	(3) Permit employees to participate in the pension and retirement systems for employees of the State of Maryland authorized under Division II of the State Personnel and Pensions Article or any other pension and retirement systems authorized by law.
13 14	(b) (1) In the exercise of the Secretary's powers under this section, the Secretary may:
15 16 17	(i) Create [and abolish any position other than positions specifically provided for in this article] ANY POSITION IN ACCORDANCE WITH STATE LAW; and
18 19 20	(ii) Subject to subsection (b-1) of this section, determine the qualifications, appointment, removal, tenure, terms of employment, and compensation of employees unless otherwise prohibited by law.
