FOR the purpose of altering the membership of the local development council that
would be formed if a video lottery facility is located in Baltimore City; requiring
that the local development council include one Delegate and one member of the
Baltimore City Council who both represent areas where the communities
surrounding the facility are located; and generally relating to a local
development council in Baltimore City.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 (c) (1) A local development council shall be established in each geographic 20 area where a video lottery facility is located.

(2) (2) Subject to paragraph (3) of this subsection, a local development council shall consist of the following 15 members appointed by the chief executive of the county in which the local development council is located, in consultation with the Senators and Delegates who represent the communities surrounding the facility and the respective county councils, city councils, or county commissioners:
