2 Baltimore City - Consumption of Alcoholic Beverages - Unlicensed Restaurants

- 4 FOR the purpose of prohibiting, with a certain exception, an establishment in 5 Baltimore City that is not licensed by the Board of License Commissioners from 6 performing certain activities, including giving, serving, or dispensing alcoholic 7 beverages on its premises; authorizing certain restaurants not licensed by the 8 Board to allow a patron to consume alcoholic beverages during a certain time 9 under certain conditions; authorizing the Baltimore City Police Department to 10 immediately close all operations of an establishment under certain circumstances; requiring the owner or operator to be given an opportunity for a 11 12 prompt hearing on when the establishment may reopen; repealing provisions concerning the establishment and registration of bottle clubs; and generally 13 14 relating to alcoholic beverages in Baltimore City.

7 8 9 10	(ii) Before the Board may approve an application and accept the registration, the applicant shall provide copies of all inspections by the appropriate agencies, a trader's license, a sales and use tax license, and a use and occupancy permit.
11 12 13	(iii) At the hearing, the Board shall determine whether to register the establishment, using the standards listed under $\S 10-202(a)(2)(ii)$ of this article.
14 15	(iv) 1. A registration of a bottle club under this subsection remains in effect for 1 year.
16 17 18	2. Subject to subparagraph (v) of this paragraph, a registration that is accepted by the Board may be renewed each year in accordance with the same renewal procedures used for liquor licenses.
