1 AN ACT concerning

### 2 Public Health - Frederick County - Dogs in Outdoor Dining Areas

- 3 FOR the purpose of authorizing the County Commissioners for Frederick County to 4 enact certain laws, ordinances, rules, or regulations to allow a restaurant to 5 allow dogs in outdoor dining areas of restaurants; requiring the legislation to 6 contain a certain prohibition; requiring the legislation to contain a provision to 7 ensure certain rights are not impeded; and generally relating to the presence of 8 animals in outdoor dining areas in Frederick County.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14
