33 SECTION [7.] 8. AND BE IT FURTHER ENACTED, That § 21–809(b)(1)(i), 34 (iii), and (v) of the Transportation Article, as enacted by Section 1 of this Act, does not

apply to speed monitoring systems installed and operated in Montgomery County
 before October 1, 2009.

3 SECTION [8.] 9. AND BE IT FURTHER ENACTED, That Section 3 of this Act 4 shall take effect October 1, 2012.

5 SECTION [9.] **10.** AND BE IT FURTHER ENACTED, That, except as provided 6 in Section [8] **9** of this Act, this Act shall take effect October 1, 2009.

10 SECTION 2. AND BE IT FURTHER ENACTED, That the publishers of the 11 Annotated Code of Maryland, subject to the approval of the Department of Legislative 12 Services, shall make any changes in the text of the Annotated Code necessary to 13 effectuate any termination provision that was enacted by the General Assembly and 14 has taken effect or will take effect prior to October 1, 2010. Any enactment of the 2010 15 Session of the General Assembly that negates or extends the effect of a previously 16 enacted termination provision shall prevail over the provisions of this section.

17 SECTION 3. AND BE IT FURTHER ENACTED, That the Drafter's Notes 18 contained in this Act are not law and may not be considered to have been enacted as 19 part of this Act.

20 SECTION 4. AND BE IT FURTHER ENACTED, That the provisions of this Act 21 are intended solely to correct technical errors in the law and there is no intent to 22 revive or otherwise affect law that is the subject of other acts, whether those acts were 23 signed by the Governor prior to or after the signing of this Act.

SECTION 5. AND BE IT FURTHER ENACTED, That the publishers of the Annotated Code of Maryland, in consultation with and subject to the approval of the Department of Legislative Services, shall make nonsubstantive corrections to codification, style, capitalization, punctuation, grammar, spelling, and any reference rendered incorrect or obsolete by an Act of the General Assembly, with no further action required by the General Assembly. The publishers shall adequately describe any such correction in an editor's note following the section affected.

31 SECTION 6. AND BE IT FURTHER ENACTED, That this Act is an emergency 32 measure, is necessary for the immediate preservation of the public health or safety, 33 has been passed by a yea and nay vote supported by three-fifths of all the members 34 elected to each of the two Houses of the General Assembly, and shall take effect from 35 the date it is enacted.
