- 3 FOR the purpose of repealing a certain benefit that is clarifying that certain death 4 benefits are payable on behalf of certain members of the State Retirement and 5 Pension System under certain circumstances; requiring the Board of Trustees of 6 the State Retirement and Pension System to pay a certain death benefit on 7 behalf of certain retirees if the retirees die under certain circumstances; 8 requiring the Board of Trustees to make certain offsets to certain benefits under 9 certain circumstances; providing for the application of this Act; and generally 10 relating to death benefits payable on behalf of retirees of the State Retirement and Pension System. 11

4 5 6	(II) THE BOARD OF TRUSTEES SHALL PAY THE BENEFITS PAYABLE ON THE RETIREE'S BEHALF AS PROVIDED UNDER § 29–202, § 29–205, OR § 29–206 OF THIS ARTICLE.
7 8 9 10	(3) THE BOARD OF TRUSTEES SHALL OFFSET ANY RETIREMENT ALLOWANCE PAYMENTS MADE TO THE RETIREE PRIOR TO THE RETIREE'S DEATH AGAINST ANY AMOUNTS PAYABLE UNDER § 29–202, § 29–205, OR § 29–206 OF THIS ARTICLE.
11 12 13 14	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply retroactively and shall be applied to and interpreted to affect the surviving spouse of any retiree who retired on or after March 1, 2008, from the Employees' Pension System and died within 30 days of retiring.
15 16	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2010.
