A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Possession of Ammunition for Firearms – Penalties**

3 FOR the purpose of prohibiting a person from possessing ammunition for a firearm if
4 the person previously was convicted of certain crimes; providing penalties for a
5 violation of this Act; defining certain terms; and generally relating to the
6 possession of ammunition for firearms.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Criminal Law**

20 **4–110.**

21 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**
22 **MEANINGS INDICATED.**

23 **(2) “CRIME OF VIOLENCE” HAS THE MEANING STATED IN § 5–101**
24 **OF THE PUBLIC SAFETY ARTICLE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.



1 **(3) "FIREARM" HAS THE MEANING STATED IN § 5-622 OF THIS**
2 **ARTICLE.**

3 **(B) A PERSON MAY NOT POSSESS AMMUNITION FOR A FIREARM IF THE**
4 **PERSON PREVIOUSLY WAS CONVICTED OF:**

5 **(1) A CRIME OF VIOLENCE; OR**

6 **(2) A VIOLATION OF § 5-602, § 5-603, § 5-604, § 5-605, § 5-606, §**
7 **5-612, § 5-613, OR § 5-614 OF THIS ARTICLE.**

8 **(C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A**
9 **MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT FOR NOT**
10 **MORE THAN 1 YEAR OR A FINE NOT EXCEEDING \$5,000 OR BOTH.**

11 5-622.

12 **(a) In this section, "firearm" includes:**

13 **(1) a handgun, antique firearm, rifle, shotgun, short-barreled**
14 **shotgun, and short-barreled rifle, as those words are defined in § 4-201 of this article;**

15 **(2) a machine gun, as defined in § 4-401 of this article; and**

16 **(3) a regulated firearm, as defined in § 5-101 of the Public Safety**
17 **Article.**

18 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
19 **October 1, 2010.**
