A BILL ENTITLED

AN ACT concerning 1 2 Commission on Surrogate Parenting 3 FOR the purpose of creating the Commission on Surrogate Parenting; providing for 4 the composition, chair, and staffing of the Commission; providing that a 5 member of the Commission may not receive compensation but may be 6 reimbursed for certain expenses; requiring the Commission to study certain 7 issues related to surrogate parenting; requiring the Commission to make 8 certain recommendations, if possible; requiring the Commission to report 9 certain findings and recommendations to the Governor and to the General 10 Assembly; providing for the termination of this Act; and generally relating to the Commission on Surrogate Parenting. 11 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That: 13 14 There is a Commission on Surrogate Parenting. It shall remain effective for a period of 1 year and 9 months and, at the end of March 31, 2012, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
