3 FOR the purpose of requiring the Maryland Technology Development Corporation and
4 the Stem Cell Research Commission to include in the Maryland Stem Cell
5 Research Fund annual report certain information on the number of patients
6 treated ~~and the amount of time until research is tested in a clinical trial~~ under
7 certain circumstances; and generally relating to the requirements of the
8 Maryland Stem Cell Research Fund annual report.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article – Economic Development**

2 (a) In this subtitle the following words have the meanings indicated.

3 (c) "Corporation" means the Maryland Technology Development
4 Corporation.

5 10-429.

6 (a) In this part the following words have the meanings indicated.

7 (c) "Commission" means the Stem Cell Research Commission.

8 (e) "Fund" means the Maryland Stem Cell Research Fund established under
9 § 10-434 of this subtitle.

10 (i) "State-funded stem cell research" means stem cell research conducted
11 with State money and using:

12 (1) material obtained in accordance with § 10-438 of this subtitle; or

13 (2) adult stem cells.

14 (j) "Stem cell" means a human cell that has the ability to:

15 (1) divide indefinitely;

16 (2) give rise to many other types of specialized cells; and

17 (3) give rise to new stem cells with identical potential.

19 (a) On or before January 1 of each year, the Corporation and the Commission
20 shall report to the Governor and, in accordance with § 2-1246 of the State
21 Government Article, the General Assembly on the progress of State-funded stem cell
22 research conducted in accordance with this part.

23 (b) The report shall identify:

24 (1) each recipient of money from the Fund;

25 (2) the amount of money awarded to each recipient; [and]

26 (3) a description of the type of stem cell research performed by ~~the~~
27 ~~EACH~~ recipient; AND

1 (4) ~~THE NUMBER OF PATIENTS TREATED AS A DIRECT RESULT OF~~
 2 ~~THE STEM CELL RESEARCH PERFORMED BY EACH RECIPIENT, WHICH SHALL BE~~
 3 ~~ZERO IF A RECIPIENT HAS NOT YET TREATED PATIENTS; AND~~

4 (5) ~~FOR EACH RECIPIENT THAT HAS NOT YET TESTED THE STEM~~
 5 ~~CELL RESEARCH IN A CLINICAL TRIAL, AN ESTIMATE OF THE AMOUNT OF TIME~~
 6 ~~UNTIL THE STEM CELL RESEARCH PERFORMED BY THE RECIPIENT WILL BE~~
 7 ~~TESTED IN A CLINICAL TRIAL. IF THE STEM CELL RESEARCH PERFORMED BY A~~
 8 RECIPIENT WITH MONEY FROM THE FUND INCLUDES A CLINICAL TRIAL, THE
 9 NUMBER OF PATIENTS TREATED AS A DIRECT RESULT OF THE FUNDED
 10 RESEARCH.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 12 October 1, 2010.
