### A BILL ENTITLED

#### 1 AN ACT concerning

# Higher Education – Death of Police Officer or Firefighter – Edward T. Conroy Memorial Scholarship Program

#### 4 FOR the purpose of waiving tuition for any child of a police officer or firefighter killed $\mathbf{5}$ in the line of duty in the State of Maryland; requiring the Governor to provide 6 in the annual budget a certain amount under certain circumstances; requiring $\mathbf{7}$ certain postsecondary institutions to allow certain students upon acceptance, 8 after meeting enrollment requirements, to enroll in certain programs and 9 attend classes for credit under these circumstances; requiring certain 10 postsecondary institutions to waive tuition for certain students; providing for the termination of certain provisions of this Act; and generally relating to the 11 12enrollment and attendance of Edward T. Conroy Memorial Scholarship 13recipients at postsecondary institutions.

takes effect, Section 1 of this Act shall be abrogated and of no further force and effect.
This Act may not be interpreted to have any effect on that termination provision.
