Property Tax Credit - Habitat for Humanity

3 FOR the purpose of authorizing the Mayor and City Council of Baltimore City or the 4 governing body of a county or municipal corporation to grant, by law, a property 5 tax credit against the county or municipal corporation property tax imposed on 6 certain real property owned by Habitat for Humanity; requiring Habitat for 7 Humanity to submit an annual report to certain governing bodies under certain 8 circumstances; authorizing the Mayor and City Council of Baltimore City or the 9 governing body of a county or municipal corporation to set, by law, the amount, terms, scope, and duration of the tax credit and to provide for any other 10 provision necessary to carry out the tax credit; providing for the application of 11 12 this Act; and generally relating to authorization for a property tax credit for certain real property owned by Habitat for Humanity. 13
