# State Retirement and Pension System – Disability Retirement Application Surviving Beneficiary

- 4 FOR the purpose of authorizing a certain beneficiary to submit an application for  $\mathbf{5}$ disability retirement under certain circumstances; requiring the Board of 6 Trustees of the State Retirement and Pension System to accept an application  $\mathbf{7}$ for disability retirement from a certain beneficiary under certain circumstances; 8 requiring the medical board to review a certain application to make a certain 9 determination under certain circumstances; requiring the Board of Trustees to 10 review a certain application to make a certain determination; requiring the 11 Board of Trustees to grant a disability retirement allowance under certain 12circumstances; requiring a certain burden of proof to be on a certain beneficiary; 13requiring a disability retirement allowance to begin at a certain time under 14 certain circumstances; providing for the application of this Act; and generally relating to an application for disability retirement submitted by a surviving 1516 beneficiary of a deceased member of the State Retirement and Pension System.

### 22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 23 MARYLAND, That the Laws of Maryland read as follows:

9 (a) Except as provided in [subsection (c)] SUBSECTIONS (C) AND (D) of this 10 section and subject to subsection [(d)] (E) of this section, an application for disability 11 retirement must be submitted before the date membership ends.

12 (b) (1) This subsection applies only to an application for an ordinary or 13 accidental disability retirement allowance filed by a member of the Employees' 14 Pension System or the Teachers' Pension System who is not subject to the contributory 15 pension benefit or the Alternate Contributory Pension Selection and who separated 16 from employment on or before June 30, 2005.

17 (2) For the purpose of submitting an application for disability,18 membership continues for 4 years after paid employment ends.

19 (c) (1) Except as provided in paragraph (2) of this subsection, the Board of 20 Trustees may accept an application for ordinary, accidental, or special disability 21 retirement from a former member within 24 months after the month membership 22 ended if the former member proves to the satisfaction of the medical board that failure 23 to submit an application while a member was attributable solely to physical or mental 24 incapacity during the filing period.

25 (2) The Board of Trustees may accept an application for ordinary or 26 accidental disability retirement from a former member of the Teachers' Retirement 27 System within 12 months after the month membership ended if the former member of 28 the Teachers' Retirement System proves to the satisfaction of the medical board that 29 failure to submit an application while a member of the Teachers' Retirement System 30 was attributable solely to physical or mental incapacity during the filing period.

(3) If the Board of Trustees accepts a disability retirement application
under this subsection and grants a disability retirement allowance, the retirement
allowance begins as of the first day of the month after the Board of Trustees receives
the application.

1 **(D)** (1) THE BOARD OF TRUSTEES SHALL ACCEPT AN APPLICATION  $\mathbf{2}$ FOR ORDINARY, ACCIDENTAL, OR SPECIAL DISABILITY RETIREMENT FROM A 3 SURVIVING BENEFICIARY OF A DECEASED MEMBER, IF THE DISABILITY 4 **APPLICATION:**  $\mathbf{5}$ **(I)** IS SIGNED AND DATED BY THE DECEASED MEMBER 6 WITHIN 1 WEEK BEFORE THE DEATH OF THE MEMBER; AND  $\overline{7}$ IS RECEIVED BY THE BOARD OF TRUSTEES ON OR **(II)** 8 BEFORE 1 MONTH AFTER THE DATE OF THE DEATH OF THE MEMBER. 9 (2) IF THE BOARD OF TRUSTEES RECEIVES AN APPLICATION 10 UNDER PARAGRAPH (1) OF THIS SUBSECTION: 11 **(I)** THE MEDICAL BOARD SHALL REVIEW THE APPLICATION 12TO DETERMINE IF THE DECEASED MEMBER WAS MENTALLY OR PHYSICALLY 13INCAPACITATED FOR THE FURTHER PERFORMANCE OF THE NORMAL DUTIES OF 14THE INDIVIDUAL'S POSITION; AND 15**(II)** THE BOARD OF TRUSTEES SHALL REVIEW THE APPLICATION TO DETERMINE THE AUTHENTICITY OF THE SIGNATURE OF THE 16 17 **DECEASED MEMBER.** THE BOARD OF TRUSTEES SHALL GRANT A DISABILITY 18 (3) 19**RETIREMENT ALLOWANCE, IF:** 20**(I)** THE MEDICAL BOARD DETERMINES THAT THE 21MEMBER WOULD BEEN DISABILITY DECEASED HAVE ELIGIBLE FOR 22RETIREMENT AT THE TIME THE DECEASED MEMBER SIGNED THE DISABILITY 23**APPLICATION; AND** 24THE BOARD OF TRUSTEES DETERMINES THAT THE **(II)** 25SIGNATURE IS VALID. 26THE BURDEN OF PROOF SHALL BE ON THE SURVIVING (4) BENEFICIARY TO ESTABLISH THE FORMAL AUTHENTICITY OF THE SIGNATURE 2728OF THE DECEASED MEMBER. 29IF THE BOARD OF TRUSTEES ACCEPTS A DISABILITY (5) 30 RETIREMENT APPLICATION UNDER THIS SUBSECTION AND GRANTS A 31DISABILITY RETIREMENT ALLOWANCE, THE RETIREMENT ALLOWANCE BEGINS 32 AS OF THE FIRST DAY OF THE MONTH AFTER THE BOARD OF TRUSTEES 33 **RECEIVES THE APPLICATION.** 

#### **SENATE BILL 709**

1 [(d)](E) (1) This subsection does not apply to an application for special 2 disability under the State Police Retirement System or an application for accidental 3 disability under the Law Enforcement Officers' Pension System or to an application for 4 accidental disability under the Correctional Officers' Retirement System.

5 (2) The Board of Trustees may not accept an application for accidental 6 disability filed by a member or former member more than 5 years after the date of the 7 claimed accident.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be 9 construed to apply retroactively and shall be applied to and interpreted to affect any 10 individual who dies on or after May 1, 2009, while employed by the State as a member 11 of the Employees' Retirement System or Employees' Pension System and an 12 application for disability is submitted by a surviving beneficiary within 1 month of the 13 death of the member.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effectJune 1, 2010.
