# 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

18 (2) "Accreditation" means the determination that a program meets 19 quality standards defined by the accrediting agency beyond State child care 20 regulations.

21 (3) "Accrediting agency" means a State agency or national 22 organization that has developed a recognized accrediting process.

5 6 7 8	(2) The purpose of the Program is to promote school readiness through the development and expansion of collaborative approaches to the delivery of high quality, comprehensive, full-day early child care and education programs and family support services.
9	(c) (1) The Program shall be funded as provided in the State budget.
10 11	(2) Funds that are allocated to the Program in the State budget may be used:
12 13	(i) To cover the costs incurred by the Department in implementing and administering the Program;

1 (ii) All participating agencies and programs that provide early 2 child care and education services through the Center have voluntarily obtained 3 accreditation or, by the date of the Grant application, have voluntarily initiated and 4 are actively pursuing the process of obtaining accreditation; and

5 (iii) The Center will provide comprehensive, full-day early child 6 care and education services and family support services.

7 (e) (1) The Department may distribute an Early Child Care and 8 Education Enhancement Grant to a county board to be used to purchase early child 9 care and education services and family support services from providers that have 10 voluntarily obtained accreditation or have voluntarily initiated and are actively 11 pursuing accreditation.

12 (2) The Department may distribute an Early Child Care and 13 Education Enhancement Grant to a private provider of early child care and education 14 services to be used:

(i) To assist the provider in voluntarily obtaining accreditation;

17 (ii) For professional development activities leading to increased 18 competency and appropriate credentialing that is related to early child care and 19 education services.

20 (f) The Department may distribute funds to a county board for the purpose 21 of implementing the Department's Early Childhood Assessment System in the 22 county's public schools.

23 (g) (1) The Department shall:

(i) Establish application procedures for obtaining Judy Center
Grants and Early Child Care and Education Enhancement Grants as provided under
this section;

(ii) Supervise and monitor the use of Grant funds distributedunder this section; and

(iii) Evaluate whether Grant recipients are meeting annual
 benchmarks established by the Department.

31 (2) For Judy Center Grants, the Department may award multiyear32 funding.

(h) A county board that is selected to receive a Judy Center Grant or an
 Early Child Care and Education Enhancement Grant for the purpose of purchasing
 early child care and education services shall:
