16 17 18	(c) (1) If the respondent appears before the court at a protective order hearing or has been served with an interim or temporary protective order, or the court otherwise has personal jurisdiction over the respondent, the judge:
19	(i) may proceed with the final protective order hearing; and
20 21 22 23	(ii) if the judge finds by [clear and convincing] A PREPONDERANCE OF THE evidence that the alleged abuse has occurred, or if the respondent consents to the entry of a protective order, the judge may grant a final protective order to protect any person eligible for relief from abuse.
