- 11 **[(e)] (F)** "Background investigation" means a security, criminal, and credit 12 investigation of a person who applies for or who is granted a license under this 13 subtitle.
- [(f)] (G) "Career offender" means a person whose behavior is pursued in an occupational manner or context for the purpose of economic gain and who utilizes methods that are deemed by the Commission as criminal violations inimical to the interest of the State.

- [(h)] (I) "Central monitor and control system" means a central system provided to and controlled by the Commission to which video lottery terminals communicate for purposes of:

- 5 [(u)] (W) "Progressive jackpot system" means a system capable of linking one or more video lottery terminals in one or more licensed facilities and offering one or more common progressive jackpots.
- 8 **[(v)] (X)** "Video lottery" means gaming or betting conducted using a video 9 lottery terminal.
- 10 **[(w)] (Y)** "Video lottery destination location" means a location that is eligible for or has been awarded in the manner provided by law a video lottery operation license.
- 13 **[(x)] (Z)** "Video lottery employee" means an employee of a person who holds 14 a license.
- 15 **[(y)] (AA)** "Video lottery facility" means a facility at which players play video lottery terminals under this subtitle.
- [(z)] (BB) "Video lottery operation license" means a license AWARDED BY
 THE VIDEO LOTTERY FACILITY LOCATION COMMISSION AND issued BY THE
 STATE LOTTERY COMMISSION to a person that allows players to operate video lottery terminals.
