1 (a) (1) A Class D beer, wine and liquor license shall be issued by the 2 license issuing authority of the county in which the place of business is located. It 3 authorizes the holder to keep for sale and sell all alcoholic beverages at retail at the 4 place described in it, for consumption on the premises or elsewhere.
