#### FISCAL AND POLICY NOTE

House Bill 910 (Delegate Malone, et al.)

Health and Government Operations Education, Health, and Environmental Affairs

#### State Government - Commemorative Days - Fire, Rescue, and Emergency Services Workers

This bill requires the Governor to annually proclaim the first Sunday in June as the day to honor the fire, rescue and emergency services workers of the State who made the ultimate sacrifice in the performance of their duties and order that the State flag be flown at half-staff. Memorial plaques containing the names of the fire, rescue, and emergency services workers who made the ultimate sacrificed must be annually placed by the Maryland Fire-Rescue Services Memorial Foundation on the Maryland Fire-Rescue Services Memorial in the City of Annapolis.

The bill takes effect June 1, 2010.

## **Fiscal Summary**

**State Effect:** Commemorating Fire, Rescue, and Emergency Services Day will not affect State finances.

**Local Effect:** None.

Small Business Effect: None.

### **Analysis**

**Current Law:** Seven official commemorative days and two months are recognized in State law as shown in **Exhibit 1**. The Governor also must issue a proclamation each year encouraging citizens and other individuals to observe a moment of silence at 3 p.m. on

Memorial Day to unite in remembrance and commemorate the heroic acts and efforts of Marylanders who have served and died in the U.S. armed forces.

**Background:** In 1997, the Maryland Fire-Rescue Services Memorial Foundation began planning for a memorial to honor the States' more than 340 firefighters and emergency medical services workers who died in the line of duty. A total of \$475,000 in State grants was provided for the memorial through the Maryland Consolidated Capitol Bond Loans (M.C.C.B.L.) of 2004, 2005, and 2008. After years of planning, design, and construction, the memorial was dedicated on June 11, 2006. Each year since, a memorial service has been held at the memorial in early June. The next memorial service is scheduled for June 6, 2010.
