<p>Chesapeake Beach, Maryland is a municipal corporation providing a broad array of public recreational services to its citizens through cooperative arrangements with Calvert County, to non-profit organizations and by direct sponsorship of groups providing recreational activities.</p>					

11. Description and Purpose of Project (Limit Length to Visible area)

The Kellam's Recreational Complex project consists of the rehabilitation of the multi-use field to include regrading, correcting drainage issues, connecting the existing irrigation system to the new re-use water (non-potable) from the waste water treatment plant, replacement irrigation, new field equipment to include bleachers, flagpoles, press box, scoreboards, speaker system, soccer, football & lacrosse goal posts, baseball field mix storage bins, dug outs and backstop fencing, security cameras and lighting, and the installation of a new 10,000 square foot skate park.
