AMENDMENTS TO SENATE BILL 692, AS AMENDED

(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the Finance Committee Amendments (SB0692/497875/1), in line 9 of Amendment No. 1, strike the second “and”; and in line 10, after “management” insert “, and with respect to inspection and maintenance standards, include a schedule for certain inspections and require a certain annual compliance plan”.

AMENDMENT NO. 2

On page 2 of the bill, in line 9, after “**(2)**” insert “**“DETAILED INSPECTION” MEANS AN INSPECTION IN WHICH INDIVIDUAL PIECES OF EQUIPMENT AND STRUCTURES, INCLUDING SUB-TRANSMISSION AND DISTRIBUTION LINES AND FACILITIES ARE CAREFULLY EXAMINED, VISUALLY AND THROUGH THE USE OF ROUTINE DIAGNOSTIC TESTS, AS APPROPRIATE, AND OPENED, IF APPROPRIATE, AND THE CONDITION OF EACH PIECE OF EQUIPMENT AND STRUCTURE IS RATED AND RECORDED.**

and in line 14, strike “**(3)**” and substitute “**(4)**”.

AMENDMENT NO. 3

On page 3 of the Finance Committee Amendments, in line 5 of Amendment No. 2, after “INSPECTIONS” insert “AND MAINTENANCE”.

On page 4 of the Finance Committee Amendments, in line 6 of Amendment No. 3, strike “AND”; and in line 12, after “INITIATIVES” insert “**;AND**”.

(IV) WITH RESPECT TO INSPECTION AND MAINTENANCE STANDARDS, INCLUDE:

1. A SCHEDULE FOR PERIODIC DETAILED INSPECTIONS OF SUB-TRANSMISSION AND DISTRIBUTION LINES, FACILITIES, AND EQUIPMENT BY ELECTRIC COMPANIES; AND

2. A REQUIRED ANNUAL COMPLIANCE PLAN TO BE SUBMITTED BY EACH ELECTRIC COMPANY TO THE COMMISSION THAT INCLUDES:

A. THE NUMBER AND TYPE OF FACILITIES THAT WERE INSPECTED IN THE PREVIOUS YEAR;

B. THE NUMBER AND TYPE OF FACILITIES THAT WERE SCHEDULED FOR INSPECTION BUT WHICH WERE NOT INSPECTED ACCORDING TO SCHEDULE, WITH AN EXPLANATION AS TO WHY THE INSPECTIONS WERE NOT CONDUCTED AND A DATE BY WHICH THE REQUIRED INSPECTIONS WILL OCCUR;

C. THE TOTAL AND PERCENTAGE BREAKDOWN OF INSPECTED EQUIPMENT, RATED BY OPERATING CONDITION, INCLUDING EQUIPMENT DETERMINED TO BE IN NEED OF MAINTENANCE, REPAIR, OR REPLACEMENT, ALONG WITH A SCHEDULE FOR THE MAINTENANCE, REPAIR, OR REPLACEMENT;

D. THE TOTAL AND PERCENTAGE BREAKDOWN OF EQUIPMENT THAT WAS MAINTAINED, REPAIRED, OR REPLACED DURING THE PREVIOUS YEAR; AND
