# <u>AMENDMENTS TO SENATE BILL 925</u> (Third Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 3, strike "certain" and substitute "<u>large</u>"; strike beginning with "<u>specifying</u>" in line 5 down through "<u>times</u>;" in line 7 and substitute "<u>providing</u> that, in a large family child care home, there may not be more than a certain number of children in certain care at certain times, and there shall be a limit on the number of children under a specified age and an adult to child ratio that comply with certain regulations; making certain requirements of law that apply to family child care homes applicable to large family child care homes;"; in line 9, after "<u>circumstances</u>;" insert "requiring the Department to adopt certain regulations on or before a certain date;"; in lines 9 and 10, strike "defining certain terms" and substitute "<u>altering certain</u> definitions"; in line 11, after "Code;" insert "<u>providing for a delayed effective date for</u> certain provisions of this Act;"; in the same line, after the second "to" insert "<u>family</u> child care and large"; in line 14, strike the third comma and substitute "<u>and</u>"; in the same line, strike the fourth comma and substitute a semicolon; and in line 17, strike "(d), 5-559.5(b)," and substitute "<u>(d), and 5-559.5(b) to be under the amended part</u> "Part V. Family Child Care Homes and Large Family Child Care Homes"; and".

#### AMENDMENT NO. 2

On page 5, in line 2, after the second comma insert "LARGE FAMILY CHILD CARE HOMES,"; after line 3, insert:

# "Part V. Family [Day] CHILD Care Homes AND LARGE FAMILY CHILD CARE HOMES.";

in line 8, strike "no more than eight"; in the same line, strike "day" and substitute "<u>CHILD</u>"; in the same line, after "home" insert "<u>OR A REGISTERED LARGE FAMILY</u>

<u>CHILD CARE HOME</u>"; and in lines 11, 12, 15, 20, and 21, in each instance, after "homes" insert "<u>AND LARGE FAMILY CHILD CARE HOMES</u>".

On page 6, in line 10, after "home" insert "<u>, LARGE FAMILY CHILD CARE</u> <u>HOME</u>,"; in lines 25 and 28, in each instance, after "home" insert "<u>AND LARGE</u> <u>FAMILY CHILD CARE HOME</u>"; and in line 32, after "home" insert "<u>OR LARGE FAMILY</u> <u>CHILD CARE HOME</u>".

On page 7, in lines 2 and 6, in each instance, after "home" insert "<u>, LARGE</u> <u>FAMILY CHILD CARE HOME</u>,"; in lines 4, 15, 16, 20, and 22, in each instance, after "home" insert "<u>OR LARGE FAMILY CHILD CARE HOME</u>"; and in lines 18, 24, 27, 28, and 30, in each instance, after "home's" insert "<u>OR LARGE FAMILY CHILD CARE</u> <u>HOME'S</u>".

On page 8, in lines 3, 18, and 28, in each instance, after "home" insert "<u>OR</u> <u>LARGE FAMILY CHILD CARE HOME</u>"; in line 25, strike "<u>STATE</u>"; and in line 27, after "home" insert "<u>, LARGE FAMILY CHILD CARE HOME</u>,".

## AMENDMENT NO. 3

On page 9, in line 23, after "<u>BE</u>" insert "<u>A LIMIT ON THE NUMBER OF</u> <u>CHILDREN UNDER THE AGE OF 2 YEARS AND</u>"; in line 24, strike "<u>COMPLIES</u>" and substitute "<u>COMPLY</u>"; in the same line, after "<u>DEPARTMENT</u>" insert "<u>UNDER § 5-551</u> <u>OF THIS PART V OF THIS SUBTITLE</u>"; and in lines 26 and 28, in each instance, after "home" insert "<u>OR LARGE FAMILY CHILD CARE HOME</u>".

On page 10, in line 25, after "the" insert "<u>UNREGISTERED</u>"; and in line 31, after "homes" insert "<u>AND LARGE FAMILY CHILD CARE HOMES</u>".

On page 11, in lines 10, 14, 17, and 18, in each instance, after "home" insert "<u>OR</u> LARGE FAMILY CHILD CARE HOME".

# AMENDMENT NO. 4

On page 16, after line 29, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That, on or before January 1, 2012, the State Department of Education shall adopt regulations that relate to the registration of large family child care homes, as required under § 5-551(a) of the Family Law Article, as enacted by Section 1 of this Act.".

On page 17, in lines 1 and 5, strike "2." and "3.", respectively, and substitute "<u>3.</u>" and "<u>5.</u>", respectively; in line 2, after "Code" insert "<u>, in consultation with and subject</u> to the approval of the Department of Legislative Services,"; in the same line, strike "reference" and substitute "<u>references</u>"; in line 3, after "care"" insert "<u>, "family day care</u> home" to be "family child care home", and "day care provider" to be "child care provider","; after line 4, insert:

"<u>SECTION 4. AND BE IT FURTHER ENACTED</u>, That Sections 1 and 3 of this Act shall take effect January 1, 2012.";

in line 5, after "That" insert "<u>, except as provided in Section 4 of this Act.</u>"; and in line 6, strike "October" and substitute "<u>July</u>".
