AMENDMENTS TO SENATE BILL 497  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Special”; in the same line, after “G” insert “Farm or”; in line 3, after “Trailer” insert “or Semitrailer”; strike beginning with “establishing” in line 4 down through “classification” in line 14 and substitute “altering the Class G farm trailer or semitrailer motor vehicle registration classification to include a livestock trailer or semitrailer; authorizing the Motor Vehicle Administration to issue a Class G farm or livestock trailer or semitrailer registration to an applicant who certifies that the applicant is a farmer, an agricultural producer, or a livestock exhibitor and that the vehicle is to be used for a certain purpose; altering certain motor vehicle registration fees; prohibiting a Class G farm or livestock trailer or semitrailer from being used for hire, except under certain circumstances; altering a certain definition; and generally relating to a special Class G farm or livestock trailer or semitrailer motor vehicle registration classification”; in line 15, strike “adding to” and substitute “repealing and reenacting, with amendments,”; and in line 17, strike “13-929” and substitute “13-930”.

AMENDMENT NO. 2

On pages 1 and 2, strike in their entirety the lines beginning with line 23 on page 1 through line 14 on page 2, inclusive, and substitute:

“13-930.

(a) In this section, “farm OR LIVESTOCK trailer or semitrailer” means a farm vehicle OR A VEHICLE USED TO TRANSPORT LIVESTOCK that is a Class G (trailer) vehicle.

(Over)

(b) On application, the Administration shall issue a special Class G “farm OR LIVESTOCK trailer or semitrailer” registration to any applicant who certifies:

(1) That the applicant is a farmer, AN AGRICULTURAL PRODUCER, OR A LIVESTOCK EXHIBITOR; and

(2) That the vehicle for which the application is made is a farm OR LIVESTOCK trailer or semitrailer, specifying its proposed use.

(c) Except as otherwise provided in this part, for each farm OR LIVESTOCK trailer or semitrailer, the annual registration fee is based on the maximum gross weight limitations for the vehicle, as follows:

<u>Maximum Gross Weight</u>	
<u>Limit (in Pounds)</u>	<u>Fee</u>
<u>[3,000]5,000</u>	<u>\$ 12.75</u>
<u>[5,000</u>	<u>25.50]</u>
<u>10,000</u>	<u>[40.00]20.00</u>
<u>20,000</u>	<u>[62.00]31.00</u>

(d) A vehicle registered under this section may not be used for hire except to haul farm products OR LIVESTOCK for another farmer.

(e) A vehicle registered under this section may not be used in any manner other than as a farm OR LIVESTOCK trailer or semitrailer.”.
