1 AN ACT concerning

2 **Environment – ~~Commercial Dishwashing Detergent – Prohibition~~**
3 **Phosphorus – Commercial Dishwashing Detergent**

4 FOR the purpose of prohibiting a person from using, selling, manufacturing, or
5 distributing for use or sale certain commercial dishwashing detergents that
6 contain greater than a certain amount of phosphorus after a certain date;
7 repealing certain obsolete language; and generally relating to phosphorus in
8 commercial dishwashing detergents.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Environment**

17 9–1503.

18 (a) Except as ~~provided in subsection (b) of~~ **OTHERWISE PROVIDED IN** this
19 section, a person may not use, sell, manufacture, or distribute for use or sale within
20 the State any cleaning agent that contains more than 0.0 percent phosphorus by

1 weight expressed as elemental phosphorus except for an amount not exceeding 0.5
2 percent phosphorus that is incidental to manufacturing.

3 (b) Except as provided in subsection (c) of this section, a person may use, sell,
4 manufacture, or distribute for use or sale a cleaning agent that contains greater than
5 0.0 percent phosphorus by weight, but does not exceed 8.7 percent phosphorus by
6 weight that is:

7 (1) A detergent used in a **COMMERCIAL** dishwashing machine[,
8 whether commercial or household]; or

9 (2) A substance the Secretary, by rule and regulation, excludes from
10 the 0.0 percent phosphorus limitation of subsection (a) of this section based on a
11 finding that compliance with this section would:

12 (i) Create a significant hardship on the user; or

13 (ii) Be unreasonable because of the lack of an adequate
14 substitute cleaning agent.

15 (c) **(1)** After ~~July 1, 2010~~ **OCTOBER 1, 2012**, a person may not use, sell,
16 manufacture, or distribute for use or sale within the State any detergent for use in a
17 ~~household~~ **COMMERCIAL** dishwashing machine that contains more than 0.5 percent
18 phosphorus by weight.

19 **(2) AFTER JULY 1, 2013, A PERSON MAY NOT USE, SELL,**
20 **MANUFACTURE, OR DISTRIBUTE FOR USE OR SALE WITHIN THE STATE ANY**
21 **DETERGENT FOR USE IN A COMMERCIAL DISHWASHING MACHINE THAT**
22 **CONTAINS MORE THAN 0.5 PERCENT PHOSPHORUS BY WEIGHT.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2011.
